## **ASSOCIATE MEMBER CATEGORY AND DUES**

- > Associate membership is divided into 6 categories (see below).
- > Membership dues are payable annually. The fiscal year of WAPA begins January 1.
- > No initiation fee is required, but annual dues are *payable in advance*.
- > Members joining after July 1 will be assessed 50% of the annual dues. Thereafter, their Associate Member dues will be invoiced on a regular full year basis.
- > Each Associate member has one vote on the Associate Member Council.
- > The Associate Member Council elects a Chair who serves for two (2) years.
- > The Associate Member Council Chair must be a Major Asphalt Refiner/ Supplier Associate Member representative in good standing. The Associate Member Council Chair has one voting seat on the WAPA Board of Directors.
- > Membership dues include partial sponsorship of Annual and Mid-Year WAPA social functions. Additional voluntary sponsorship opportunities may be solicited by the Associate Chair as authorized by the Associate Member Council.
